Reimbursement Rates

This list contains some of the most common items and their associated cost. As every situation may vary, there may be additional items and costs to be considered. Use this list as a guide.

Examples of Estimated Easement Expenses

Appraisal: \$4,500-\$6,500
Legal Services: \$3,000-\$4,500
Survey*: VOF will determine the need for a survey
Title Work: \$500-\$750
Lender's Easement & Mortgage Review: \$2,500
VOF Baseline Documentation Report (BDR) Fee: \$3,000-\$3,500
